



Admission Criteria for DIPSITES (based on Pre-Board–I & II) to Class XI, 2025-26

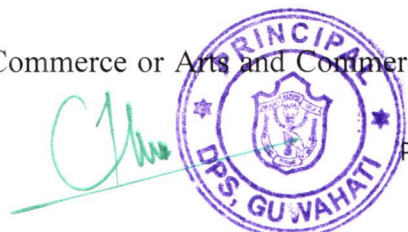
Greetings from DPS Guwahati!

Looking into the vastness of the course content of Class XI the academic session 2025-26 shall commence on 2nd April 2025 (Wednesday). The admission criteria for **DIPSITES** based on Pre-board – I & II examinations is as given below:

* It is mandatory for the students to **pass in all the main subjects in PB I / II** to take provisional admission in Class XI for the session 2025-26.

- Students will be allowed to change from Science stream to Commerce or Arts and Commerce stream to Arts (vice –versa will not be considered).



2. They will also be allowed to change subjects within the stream after the declaration of the AISSE-2025 results.
3. Admission Forms for Dipsites are now available in the school website which can be downloaded.
4. To get priority for admission in DPS Guwahati, Dipsites must submit the duly filled in admission form in the school admin office in hard copy from 04.01.2025 to 30.01.2025 and secure their seat by paying a non-refundable Activity fee of Rs. 37,500/-for day school and Rs. 61,700/- for boarders for the academic session 2025-26 latest by 08.02.2025
5. Selection of students after declaration of final board result will be purely based on the availability of seats and **new admission criteria** set at that time.
6. Having met the above criteria, the admission of students will remain **PROVISIONAL** till the declaration of board results. For science and commerce stream, it is mandatory for students to pass all the main subjects in the board exam.
7. **NO SEPARATE ADMISSION TEST WILL BE CONDUCTED FOR DIPSITES.**


SCHOLARSHIP CRITERIA For DIPSITES

1. There are 10 seats reserved for 100% scholarship **only for dipsites**. In case of more applicants, a merit list will be prepared and accordingly top 10 students will be allotted the scholarships.
2. Scholarship to students shall only be based on the final board result after re-evaluation marks are announced by the board.
3. **Students securing 95% and above marks**, individually in four mainstream subjects i.e, English, Mathematics, Science and Social Science in the AISSE 2025 **may apply**. The details of **payment to be made under 100%** Scholarship scheme is as given below:

4. Dipsites who qualify for the Scholarship will get their deposited fee refunded as applicable.
5. The validity of the scholarship is for two successive/continuous academic sessions from the date of admission, provided the student is promoted to Class XII with at least **75 percent** marks in individual five main subjects of the scheduled examinations as notified/printed in the almanac. Also note that even if the retest is conducted for general category, it will not be valid to continue the scholarship. Thereafter, the **scholarship will be withdrawn** automatically in class XII without any intimation and thereby, the student/parent/ guardian will have to pay the fee for class XII as per the fee structure of the school for the academic session 2026-27.
6. **100% scholarship** students applying for **boarding facility** will pay only the boarding fee and will get full freeship in Admission, Activity and Tuition fee. (Pl. refer the above table for details).
7. Admission to class XI and grant of scholarship; and continuation of it in class XII is the sole jurisdiction of the school management which shall be final and binding in all respects.
8. Students who have been granted scholarship will have to deposit **scholarship caution money*** of **Rs. 25,000/-** which will be refunded only if the student availing the scholarship completes Classes XI & XII from DPS Guwahati and also abides by the scholarship criteria in Class – XII.
9. If any student availing scholarship applies for transfer certificate he/she must pay the entire school fee till the date of issue of TC.
